

Export Check list Prior coming to Maersk Line for OBL collection or OBL surrender or Telex Release.

Original B/I Collection

- Copy of the Invoice.
- Copy of the Final B/L draft updated with ED number and ED shipper.
- Export Declaration (ED) copy.

Original B/I Surrender / Telex Release

- Shippers authorisation letter specifying whom to release the cargo.
- 3/3 Original Bill of Lading.
- Surrender Fee of AED 200.

Late B/I Fee Tariff - (From Vessel Sailing Date) *

- USD 50/ - for late b/l pick up from 11 to 20 days
- USD 100/ - for late b/l pick up from 21 to 30 days
- USD 200/- for late b/l pick up from 31 to 45 days
- USD 500/ - for late b/l pick up from 46 + days

Payment Note:

Payment below AED 2,000/- and above AED 50,000/- should be made by Cash or on Demand Draft.
