Please note that Bayhead Road is open under the strict supervision of Law Enforcement Authorities.

Pier 1 will commence with appointments slots for specific blocks from 12h00 today. The availability of slots is being restricted due to the limited access on Bayhead Road to avoid creating congestion as other businesses in the precinct will be using Bayhead Road as well.

Imports

- Imports will be released for block A1,A2,A3, F2,D2,G2,G3 , ALL REEFERS AND EMPTIES
- 30 slots will be allocated per hour,
- Import storage last free day will be communicated as per the published import storage schedule and extensions granted when necessary

Exports: Export stacks will be communicated.

Important Note

- Appointments can be made from 12h00
- Slots must be cancelled a minimum of 30 minute before the confirmed slot time. If slots are not cancelled on time that transport company will not be allowed to book appointments for the next 12 hours.
- Transporters that waste slots will not be allowed to book slots for the next 24 hours.
- Law Enforcement Authorities will only allow transporters with confirmed appointments to access on Bayhead Road. Do not dispatch a truck without an appointment, they will be turned away.
