Please note that Bayhead Road is open under the strict supervision of Law Enforcement Authorities . **The procedure for the evacuation of Critical Cargo remains the same. For General Cargo which includes Reefers and IMDG for specific vessel listed below will be available via the Container Appointment System.**

Pier 2 commenced making appointments slots available for specific towers from 18h00 yesterday. Additional vessels have been added as indicated below. The availability of slots is being restricted due to the limited access on Bayhead Road to avoid creating congestion as other businesses in the precinct will be using Bayhead Road as well.

- Transporters that waste slots will not be allowed to book slots for the next 24 hours.
- Law Enforcement Authorities will only allow transporters with confirmed appointments access on Bayhead Road. Do not dispatch a truck without an appointment, they will be turned away.
